Ralph M. Brown Act. Gov. Code § 54950. In enacting this chapter, the Legislature finds and declares that the public commissions, boards and councils and the other public agencies in this State exist to aid in the conduct of the people's business. It is the intent of the law that their actions be taken openly and that their deliberations be conducted openly. The people of this State do not yield their sovereignty to the agencies, which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created.

A. 2022 Events

Staff informed the Commissioners that the Dumpster Day event has been confirmed for Saturday, October 1, 2022 and the Coastal Cleanup event has been confirmed for Saturday, September 17, 2022.

Staff provided the Commissioners with an update on community events. All events will be returning to in person this year and a Fourth of July fireworks show will be offered. The egg hunt will be held at Fernandez Park on April 9, 2022. Movies and concerts will return to Fernandez Park this summer. More information on the community events will be available in the coming months.

Commissioner Ojeda also informed the Commission that the Pinole Community Players will host a cabaret night in March.

B. Staff Update

Staff informed the Commissioners that Misha Kaur from the Public Works Department will serve as the lead with the Dumpster Day and Coastal Cleanup events moving forward. The recreation manager will continue to support with monthly meetings and other Community Service Commission tasks.

C. Meeting Format

Staff informed the Commissioners that the City Council directed staff to return to a hybrid model for in person meetings starting on March 15. 2022. Staff will receive training on the process for meetings in the next coming weeks. The Community Services Commission March meeting will be held in a hybrid model. The meetings will be moved to the Council Chamber when we resume in person meetings. Staff will provide more information as it is available.

D. May Meeting

Staff informed the Commissioners that the May meeting was rescheduled to June 1 due to PCTV's availability to support with broadcast. The meeting for June 22 will be moved to June 29 to allow for a four week break between each meeting. The Commission approved the schedule change for the May and June meeting.
