Ralph M. Brown Act. Gov. Code § 54950. In enacting this chapter, the Legislature finds and declares that the public commissions, boards and councils and the other public agencies in this State exist to aid in the conduct of the people's business. It is the intent of the law that their actions be taken openly and that their deliberations be conducted openly. The people of this State do not yield their sovereignty to the agencies, which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created.

SUBJECT: RESOLUTION RATIFYING PROCLAMATION OF LOCAL

**EMERGENCY** 

#### **RECOMMENDATION**

Staff recommends that the City Council adopt a resolution ratifying the Director of Emergency Services' proclamation of a local emergency.

#### **BACKGROUND & DISCUSSION**

On March 18, 2020 the City Manager, acting as Director of Emergency Services, proclaimed a local emergency pursuant to California Government Code Section 8630 and Pinole Municipal Code Chapter 2.32. The emergency declaration was based on public health and safety concerns for persons and property within the City as a consequence of the global spread of novel coronavirus 2019 ("COVID-19"), including confirmed cases in Contra Costa County, as well as, the Contra Costa County Department of Health's shelter in place order dated March 16, 2020.

Pursuant to applicable law, the proclamation by the Director of Emergency Services terminates after seven (7) days unless ratified by the City Council. This item requests that the City Council adopt a resolution ratifying the Proclamation of Local Emergency issued by the Director of Emergency Services, and authorize the Director of Emergency Services to make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by such local emergency.

Declaring a state of emergency provides local governments with the powers necessary to coordinate and implement plans aimed at protecting people and property during a disaster. For example, a declaration of emergency is often necessary to secure mutual disaster aid from local, state and federal agencies. A declaration of emergency also permits a local governing body to promulgate orders and regulations necessary for the protection of life and property, such as imposing a curfew and ordering use of facilities for governmental purposes. Additionally, declaring a state of emergency ensures that the local government and its officials and employees are immune from liability when exercising their official duties during an emergency.

If adopted, the declaration of emergency will remain in place until the emergency conditions have ended. However, pursuant to State law, the City Council is required to review the declaration at least every 60 days.

#### **FISCAL IMPACT**

There is no direct fiscal impact from the adoption of the resolution ratifying a local emergency. However, the City will consider all options available to seek reimbursement for indirect expenses and fiscal impacts through the appropriate authorities.

## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PINOLE RATIFYING THE PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY BY DIRECTOR OF EMERGENCY SERVICES

**WHEREAS**, Government Code Section 8630 and Pinole Municipal Code Section 2.32.060 authorize the Director of Emergency Services to proclaim a local emergency when conditions of disaster or extreme peril to the safety of persons and property within the territorial limits of a city exist if the City Council is not in session and provides that the City Council shall ratify the proclamation within seven days thereafter; and

WHEREAS, in accordance with Government Code Section 8630 and Pinole Code Section 2.32.060, the Director of Emergency Services proclaimed the existence of a local emergency caused by the Novel Coronavirus (COVID-19), a respiratory disease first identified in China that may result in serious illness or death that is easily transmissible from person to person, on March 18, 2020; and

**WHEREAS**, on January 30, 2020 the World Health Organization declared the COVID-19 outbreak a "public health emergency of international concern"; and

**WHEREAS**, on January 31, 2020, the United States Department of Public Health and Human Services Secretary declared a public emergency for COVID-19, and on March 4, 2020 the Governor of the State of California declared a state of emergency in the State of California due to the number of confirmed cases of COVID-19 in the State; and

**WHEREAS**, on February 25, 2020, the Centers for Disease Control and Prevention announced that community spread of COVID-19 is likely to occur in the United States; and

**WHEREAS**, on March 10, 2020, the Contra Costa County Board of Supervisors declared a local health emergency; and

**WHEREAS**, on March 11, 2020, the World Health Organization declared COVID-19 a pandemic; and

**WHEREAS**, on March 12, 2020, Governor Gavin Newsom issued a new executive order further enhancing state and local government's ability to respond to the COVID-19 pandemic; and

**WHEREAS**, on March 13, 2020, the President of the United States, declared a state of national emergency in response to the COVID-19 pandemic; and

**WHEREAS**, state and local health officials report that sustained human-to-human transmission of the virus is occurring; and

**WHEREAS**, on March 16, 2020, the Contra Costa Health Officer issued an order for all individual living in the County to shelter at their home, except with limited exceptions to receive or provide essential services or engage in essential activities, in order to minimize the extent of community-acquired transmission of COVID-19; and

**WHEREAS**, the health, safety, and welfare of Pinole residents, businesses, visitors, and staff is of utmost importance to the City and additional future measures may be needed to protect the community; and

**WHEREAS**, the City may require additional assistance in the future, and a formal declaration of emergency allows the City to access resources in a timely manner in a timely fashion; and

**WHEREAS**, the City Council finds that the aforesaid conditions are of extreme peril to the safety of persons and property within the territorial limits of the City and existing conditions related to the COVID-19 pandemic did warrant the proclamation of emergency, as defined by Pinole Municipal Code Chapter 2.32 and as defined by State law; and

**WHEREAS**, the City Council finds that extraordinary measures are required to protect the public health, safety, and of persons and property within the City that are or are likely to be beyond the control or capability of the services, personnel, equipment, and facilities of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Pinole hereby ratifies and confirms the Proclamation of the Existence of a Local Emergency issued by the Director of Emergency Services, dated March 18, 2020, attached to this Resolution as Exhibit A.

**BE IT IS FURTHER RESOLVED** by the Council that because a substantial threat to public health and safety exists that has a substantial likelihood that serious harm will be experienced unless immediate action is taken, the City will need to alter or cease certain services other than essential services in response to this emergency. The City Manager is authorized to take any lawful personnel action that protects the health and safety of the workforce or the community

**BE IT FURTHER RESOLVED** that during the existence of said local emergency the powers, functions, and duties of the City Manager, acting as Director of Emergency Services, and the emergency organization of this City shall be those prescribed by State law and by ordinances and resolutions of the City of Pinole.

**BE IT FURTHER RESOLVED** by the Council that the local emergency shall remain in effect until such time that the Council determines that the emergency conditions have been abated.

**BE IT FURTHER RESOLVED** that City staff is directed to place an item on the agenda for review at least every sixty (60) days from the effective date of this Resolution to determine the need for continuing the local emergency pursuant to Government Code Section 8630.

**BE IT FURTHER RESOLVED** that this Resolution shall become effective immediately upon its passage and adoption.

## PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY BY DIRECTOR OF EMERGENCY SERVICES

WHEREAS, Government Code Section 8630 and Pinole Municipal Code Chapter 2.32 empower the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the City is affected or likely to be affected by conditions of extreme peril to the safety of persons and property within the City; and

WHEREAS, Pinole Municipal Code Chapter 2.32 designates the City Manager as the Director of Emergency Services; and

WHEREAS, Government Code Section 8558(c) defines a local emergency as "the duly proclaimed existence of conditions of disaster or of extreme peril to the safety of persons and property within the territorial limits of a county, city and county, or city, caused by conditions such as . . . epidemic . . . which are or are likely to be beyond the control of the services, personnel, equipment, and facilities of that political subdivision and require the combined forces of other political subdivisions to combat"; and

WHEREAS, the Novel Coronavirus (COVID-19) is a respiratory disease first identified in China that may result in serious illness or death and is easily transmissible from person to person. As of March 15, 2020, it has been reported that COVID-19 has spread to over 144 countries and territories including the United States, and is spreading to a growing number of California cities and counties; and

**WHEREAS**, on January 30, 2020, the World Health Organization declared the COVID-19 outbreak a "public health emergency of international concern"; and

WHEREAS, on January 31, 2020, the United States Department of Public Health and Human Services Secretary declared a public emergency for COVID-19, and on March 4, 2020 the Governor of the State of California declared a state of emergency in the State of California due to the number of confirmed cases of COVID-19 in the State; and

WHEREAS, on February 25, 2020, the Centers for Disease Control and Prevention announced that community spread of COVID-19 is likely to occur in the United States; and

WHEREAS, on March 10, 2020, the Contra Costa County Board of Supervisors declared a local health emergency; and

WHEREAS, on March 11, 2020, the World Health Organization declared COVID-19 a pandemic; and

**WHEREAS**, on March 12, 2020, Governor Gavin Newsom issued a new executive order further enhancing State and local government's ability to respond to the COVID-19 pandemic; and

**WHEREAS**, on March 13, 2020, the President of the United States, declared a state of national emergency in response to the COVID-19 pandemic; and

**WHEREAS**, State and local health officials report that sustained human-to-human transmission of the virus is occurring; and

**WHEREAS**, on March 16, 2020, the Contra Costa Health Officer issued an order for all individuals living in the County to shelter at their home, except with limited exceptions to receive or provide essential services or engage in essential activities, in order to minimize the extent of community-acquired transmission of COVID-19; and

**WHEREAS**, the health, safety and welfare of Pinole residents, businesses, visitors and staff is of utmost importance to the City and additional future measures may be needed to protect the community; and

WHEREAS, the City may require additional assistance in the future, and a formal declaration of emergency allows the City to access resources in a timely manner in a timely fashion; and

WHEREAS, existing conditions related to the COVID-19 pandemic warrant the proclamation of emergency, as defined by Pinole Municipal Code Chapter 2.32 and as defined by State law; and

**WHEREAS,** the Director of Emergency Services of the City of Pinole does hereby find that extraordinary measures are required to protect the public health, safety, and of persons and property within the City, that are or are likely to be beyond the control or capability of the services, personnel, equipment, and facilities of the City.

**NOW THEREFORE, I HEREBY PROCLAIM** that based on the circumstances identified above, a local emergency exists within the City of Pinole due to the COVID-19 pandemic.

**BE IT FURTHER PROCLAIMED** that during the existence of said local emergency, the powers, functions and duties of the Director of Emergency Services shall be those prescribed by State law and the ordinances and resolutions of this City.

**BE IT FURTHER PROCLAIMED AND ORDERED** that all City officers and employees take all steps directed by the City Manager to prevent the spread of COVID-19 and to prevent or alleviate illness or death due to COVID-19.

**BE IT FURTHER PROCLAIMED AND ORDERED** that all City officers and employees take all steps directed by the City Manager to qualify the City for reimbursement from the Federal Emergency Management Agency and for other State and federal relief as may

be available to reimburse the City for the expenses it incurs in addressing this local emergency.

BE IT FURTHER PROCLAIMED AND ORDERED that because a substantial threat to public health and safety exists that has a substantial likelihood that serious harm will be experienced unless immediate action is taken, the City will need to alter or cease certain services other than essential services in response to this emergency, and the City Manager can take any lawful personnel action that protects the health and safety of the workforce or the community. The City is authorized to postpone and/or delay any associated meet and confer obligations when taking actions in response to the emergency.

**BE IT FURTHER PROCLAIMED** that this Proclamation shall remain in effect for the next seven (7) days, and hereafter by ratification of the City Council pursuant to Government Code Section 8630.
