Re: Agenda item 12A – Receive information regarding options to prohibit the creation of new gas stations and the expansion, reconstruction, and relocation of existing gas station in Pinole

Dear Mayor Toms, Vice Mayor Sasai, and Council Members Murphy, Tave and Martinez-Rubin,

Thank you for placing this item on your agenda. 350 Contra Costa is strongly in favor and enthusiastic about the Pinole City Council's consideration of prohibiting new gas station infrastructure in Pinole.

350 Contra Costa, founded in 2018, is a grassroots non-profit that focuses on education and advocacy for local climate policy solutions that support equity and enable local communities to thrive as we transition to a clean energy economy. We work in alignment with our regional nonprofit, 350 Bay Area and have supported from afar city actions in Sonoma and Napa that have taken the step you are considering. The cities and counties that have adopted these policies since 2021 have reported no unintended consequences. We are hopeful that Pinole will be the first Contra Costa County municipality to prohibit new gas stations and expansion, reconstruction, or relocation of existing gas stations.

In October of 2021, your Pinole Council adopted Resolution 2021-93, declaring a climate emergency, and directing Staff to take action in line with this declaration. You followed through on your GHG Emissions Inventory and Climate Action and Adaptation planning and will soon have a roadmap for further action to reduce greenhouse gas emissions and create plans for a resilient Pinole.

A Municipal Code that permits the construction of new gas stations is inconsistent with the intent of your Climate Emergency Resolution and your Climate Action Plan.

Moving toward a Pinole prohibition, as noted in your Staff report, aligns with the statewide policy trajectory toward decarbonization. In August 2022, the California Air Resources Board formalized the Governor's Executive Order of 2020 ceasing registrations of new gas cars by

2035.3 All of the major auto makers are committed to increasing production of electric vehicles to meet this goal.

Your recent GHG emissions inventory pinpoints truck and car emissions as 41% of your total greenhouse gas emissions. As you work to reduce vehicle miles traveled in your Climate Action Plan, you would be working against this goal to permit new gas stations.

There are multiple other reasons to support a prohibition on new gas stations in Pinole:

- Every new gas station creates a new toxic site. Inevitable leaks and spills pollute surface and groundwater, and soils, impacting human health and wildlife habitats. Gas fumes also pollute the air with toxic chemicals, most harmful the closer to the source that you are.
- The health impacts on humans are a longstanding and ongoing environmental justice issue. Harms to indigenous, low income and communities of color occur all along the supply chain from extraction to transport, to refineries. Locations of gas stations, as well, affect these same populations disproportionately. Disallowing new gas stations is a step aligned with environmental justice.
- There is the possibility of a proposal for a new gas station in Pinole. New gas stations are designed to last at least forty years. Long before that time elapses, we will need to have weaned ourselves from gasoline to have a livable planet.
- The approximately 20 current operating gas stations that serve the Pinole area community should be more than adequate as we transition to zero emission vehicles over the coming decade.

350 Contra Costa has supported other actions you have taken toward a clean energy economy and equitable sustainable future for Pinole and we appreciate your leadership on these issues in our County. We stand ready to work with you on this issue, if helpful, and thank you for taking leadership to pursue steps to prohibit new gas stations in Pinole. A first for our County.
