### **RECOMMENDATIONS**

Review and comment on request for changes to existing conditions:

- A. Fern at San Pablo Avenue - sight distance
- B. Pinole Valley Road at Savage Avenue – speed and use of crosswalk
- C. Pinon near Appian – curve ahead sign

### **BACKGROUND**

- A. Concerns by an area resident has been raised regarding the difficulty is discerning a gap in traffic in which to enter the flow on San Pablo Avenue. The area resident says the concern has been compounded by the parking of cars in along San Pablo Avenue. I have visually inspected the area and reviewed the plans for the bulb outs and feel the design is serving as intended. Additional time and vigilance is required to navigate this intersection. Alternative routes of travel are available. The City Engineer has no recommendations to make for your consideration.



- B. Concern has been raised that a stop is necessary to be able to cross the street to the park. Conditions have not changed in this area, although the traffic speed of travel was also raised as a component of the concern. Speeding is an enforcement issue. The City Engineer recommendation is to increase enforcement activities.



- C. The property manager on behalf of the property owner has complained about repeated damage to the private improvements and feels signage would provide relief from such damage. The City Engineer has no recommendations to make for your consideration.
