<u>John Corcoran</u>, a resident of Pinole, stated his opposition to Measure P due to cost. He asked questions and City Manager Fitzer provided responses.

<u>James Tillman</u>, resident of Pinole, reiterated his concern and opposition to Measure P. He inquired on the status of various projects throughout the City.

Bob Kopp, resident of Pinole and member of the Community Service Commission informed Council and the public of the upcoming Community Cleanup event scheduled for Saturday, June 2, 2018 from 8:00 a.m. to 12:00 p.m., continental breakfast will be provided. Residents are encouraged to call and provide locations in need of cleanup. He also invited the community to the Car Show event on Saturday, June 24, 2018 on San Pablo Avenue.

<u>Trustee Mister Phillips</u>, West Contra Costa Unified School District, addressed the City Council to invite the Pinole Community to the 2nd Annual Building and Construction Trades Career event on Saturday, April 21, 2018 in Richmond. The career fair is for middle and high school students of the District. No RSVP needed.

Brandon Cody, resident of Pinole, stated his concern with Measure P due to cost. Mr. Cody asked questions and was directed to the City's website to review past Council meetings on discussion of Term Limits.

Irma Ruport, resident of Pinole, expressed her opposition to Repeal Term Limits - Measure P.

<u>David Ruport</u>, resident of Pinole and a member of Pinole for Fair Government stated his opposition to Measure P and provided an update on the efforts done opposing the measure.

<u>Mary Horton</u>, resident and former Mayor of Pinole, expressed her support of Measure P and the importance of continuity.

<u>Steven Dorsey</u>, department representative of IAFF Local 1230, stated his concern on the purchase of refurbished fire apparatus. He inquired about funding allocation for fire department purchases in current and past budgets.

Eric Datanagan, President of Bayfront Chamber of Commerce, introduced himself to Council and the community. He will be returning with periodic updates for the community.

A. Adopt a Resolution Approving an Increase in Sewer Connection Fees for Residential and Commercial Accounts

[Action: Approve Resolution Per Staff Recommendation (M. Fitzer/T. Miller)]

City Manager Fitzer and Development Services Director/City Engineer Miller presented the report and stated that the increase in sewer connection fees is for new construction throughout the City; this will not impact existing services.

Amelia Timbers, Senior Project Manager presented the report and provided background information on the Community Choice Aggregation program, and the process of initiating the transition of Pinole accounts from Pacific Gas and Electric to Marin Clean Energy. Council asked questions and received responses.

ACTION: Motion by Council Members Toms/Long to direct staff to opt out of MCE for the Sewer Treatment Plant until such time as contracts allow to opt back into MCE and opt out of any accounts that have photovoltaic until after the true up period concludes and any other accounts the City elects to stay in; at that time Council authorizes staff to automatically opt back into MCE, when triggers have occurred. Council requests a reevaluation of program one year after the last account is enrolled.
