Finance Director Skoda presented the report and provided an update on EDMUB Operational Activities and strategic plan. She presented an overview of costs and biennial budget for FY 18 and FY 19 with a breakdown of water rate increases. Director Young provided Council an update on current efforts that EBMUD has taken to deliver clean safe waters. Council asked questions, received responses and thanked them for the presentation.

c. Public Works Department Update on Cease and Desist Order by Senior Project Manager, Amelia Timbers

Senior Project Manager Timbers presented the report and provided an update on the Cease and Desist order issued to the City of Pinole and the efforts taken by the City to meet compliance needs including next steps. Council asked questions and received responses.

<u>Jeff Rubin</u>, President of the Pinole Historical Society, invited Council and the community to attend the "Inaugural Fundraiser and Dinner" on Saturday, October 13, 2018 from 5 pm to 8 pm at St. Joseph School auditorium. Tickets are \$25 and can be purchased by mailing a check

payable to *Pinole History Museum* c/o Pinole History Museum, P.O. Box 285, Pinole, CA. Mr. Rubin encouraged community members to purchase tickets that will be donated to students throughout the District.

<u>Sal Spataro</u>, resident of Pinole, addressed the Council and expressed his opposition to Measure C.

Nancy Lee Martin, resident of Pinole, addressed the Council and expressed her concern with staffing issues at the Fire Department and the cost of Measure P. City Manager Fitzer provided a response to her questions and concerns.

<u>David Rupport</u>, resident of Pinole and representative of Pinole 4 Fair Government, addressed the Council and provided a response to a question submitted to the Contra Costa Times.

<u>Rafael Menis</u>, resident of Pinole and City Council candidate, addressed the Council and stated his concern with the City's budget and projected revenue. He gave an update of his campaign efforts.

<u>Mary Horton</u>, former Mayor of Pinole, addressed the Council and the community expressing her support of Measure C and the benefits.

<u>Irma Ruport</u>, resident of Pinole, addressed the Council and encouraged voters to carefully consider past performance of the City Council before voting and endorsed candidates Anthony Tave and Vincent Salimi for City Council.

<u>Debbie Long</u>, resident of Pinole, addressed the Council and provided an overview of Council meetings and efforts for the City and its residents.
