General

 - "along with proposed personnel and an estimate of the time (hours per staff member) it will take to complete each task"
- 1. Change Appendix A Proposal Requirements to replace:
 - "The total number of pages must not be more than 10 pages. Appendixes/Resumes are not included in the page count"

with:

"The total number of pages must not be more than 15 pages. Appendices/Resumes and Cost Proposal (submitted separately) are not included in the page count."

All other items of the documents shall remain unchanged. Proposers are hereby notified that they shall make any necessary adjustments in their proposals and estimates as a result of this Addendum No. 1. It will be construed that each consultant's proposal is submitted with full knowledge of all modifications and supplemental data specified herein.

Questions & Responses

Question 1: Would the City accept electronic submittals via email or secure file transfer for

responses for this RFP?

Question 2: Could you confirm what you have available for consultant budget versus

construction budget for the project? Does the \$275 encompass both?

Response: The adopted budget for FY 2023/24 - 2027/28 includes a Capital Improvement

Plan budget of \$275,000 for all work on this project.

Question 3: Per the RFP, "Consultant, at its own cost and expense, shall maintain

commercial general and automobile liability insurance for the term of this Agreement in an amount not less than TWO MILLION DOLLARS (\$2,000,000) per occurrence and FOUR MILLION DOLLARS (\$4,000,000) aggregate, combined single limit coverage." Should Consultant only maintain automobile insurance in the amount of \$1,000,000, can Consultant supplement this with its

umbrella policy? Alternatively, can a waiver be granted in this regard?

Response: Please note that a waiver or alternative insurance will be evaluated on a case

by case basis by the City Attorney. Unfortunately, we are unable to provide any

assurance that a modified insurance will be accepted at this stage.

Question 4: The RFP states on page 12/34, "Please feel free to add as many sheets of

paper as you would like to your proposal to describe your qualifications and

other sections covered in this RFP."

Also, on page 12/34, the RFP states, "The total number of pages must not be more than 10 pages. Appendixes/Resumes are not included in the page count."

Could the City please clarify the page limit?

You have requested this information in two places, please confirm that the

Letter as well as the Contract Agreement, and also on the Appendix C – Cost

Proposal coversheet page which is to be submitted separately. We have

the statement is acceptable in the letter due to the page limit.

Question 16: What information do you want included under the Section titled State Only
