Councilmembers supported the concept of the proposal but had questions on cost of the extra services which Con-fire could provide.

<u>Vincent Wells</u>, Local 1230 Representative, stated that the employees of all three agencies, Con-Fire, Rodeo-Hercules and Pinole, support the concept of Joint Administrative Fire Chief Services. They would support the concept only if it was a 50/50% shared cost.

At 7:50 P.M., Mayor Swearingen closed the meeting for public comment.

The City Council discussed methods to determine the appropriate shared cost between Rodeo-Hercules and Pinole which including evaluating the cost based on population and/or calls for services.

City Manager Fitzer requested direction from the City Council to proceed with a contract to carefully examine any and all the issues the Council had and could bring back the contract for discussion.
