<u>David Ruport</u>, resident of Pinole, addressed the Council and stated his concern with the current condition of the Library and encouraged Council to explore possible upgrades to the facility and services for residents of the community.

<u>Sal Spataro</u>, resident of Pinole, addressed the Council and stated his concern on the current condition of the Public Library, hours of operation and encouraged Council to explore funding and upgrades to the site. He expressed his belief that the library is filled with opportunities for youth to enrich their education.

<u>Anthony Gutierrez</u>, resident of Pinole, addressed the Council and stated his desire to raise awareness of Opioid Addictions.

8. PUBLIC HEARINGS

A. Adopt a resolution authorizing the submission to voters a measure to repeal existing councilmember Term Limits as part of the June 5, 2018 regularly scheduled statewide election

[Action: Approve Resolution Per Staff Recommendation (E. Casher)]

City Attorney Casher presented the report and provided an overview of the proposed measure and the wording that will be presented to the voters.

Councilmember Long read into the record a statement in regards to the proposed repeal of existing councilmember Term Limits and community concerns.

Mayor Pro Tem Murray stated his support for the ballot measure and stated that the community should decide whether term limits should continue or be repealed.

Councilmember Toms stated that the item of repealing term limits was presented to the Council and focused on allowing members of Council to serve on regional level committees for extended periods of time. The workshop that was held in July 2017 to discuss term limits was not well attended and community input was not received.

Councilmember Swearingen provided the community a brief history on the term limit measure approved by voters in 2008. He expressed his support in having informed and knowledgeable Council members serving on regional boards.

Mayor Banuelos provided the community with insight on the roles and responsibilities of the City Council and the benefits of having seasoned Council members serving on regional boards and representing the City of Pinole.

At 8:42 p.m., Mayor Banuelos opened the Public Hearing; the following speakers addressed the Council:

David Ruport, resident of Pinole, addressed the Council and stated his opposition to term limits, and his concern with Council repealing the established Term Limits.

Sal Spataro, resident of Pinole, addressed the Council and stated his opposition to eliminating term limits due to the financial cost of placing the item on the ballot.

Jeff Rubin, resident of Pinole, addressed the Council and provided his concern with eliminating Council term limits and the lack of qualified candidates available to serve the City of Pinole. Mr. Rubin suggested that the City host a leadership program to encourage residents of Pinole to actively participate and join boards, commissions and possibly the City Council.

Anthony Gutierrez, resident of Pinole, addressed the Council and stated his opposition to repealing term limits. He stated his observation of the new administration and complimented their success due to their professionalism and not their institutional knowledge.

William Horton, resident of Pinole, addressed the Council and stated his support to repeal term limits and allow Pinole voters to decide the outcome of the measure.

<u>Vincent Wells</u>, President of Local 1230 Professional Firefighters union, addressed the Council and said that everybody has term limits - he has been elected for 5 terms of 2 years each - the term limit is when the people get tired of him representing them and the same is true for Council. He stated he was not here to speak for or against Council term limits, but that a change is needed on the City Council. He went on to state that the relationship between Fire and the Council has been damaged since the recall and that this Council has done nothing to address deficiencies in the Fire service, which has deteriorated under this Council.

Mary Horton, resident of Pinole, addressed the Council and stated her opposition of term limits and noted that incumbents are not guaranteed re-election. She noted the importance of institutional knowledge and the benefits it provides community members. Mrs. Horton praised Council for their dedication to the community.

Council provided responses to the various comments made by speakers, in particular to the comments of Mr. Wells. Mayor Pro Tem Murray stated that the City has been trying to work on improving the relationship with the Fire Department, and that Mr. Wells' comments took us several steps backwards. Council member Long listed several things that the City has done regarding Fire service in Pinole, including spending over a year working with Con Fire and RHFD on a joint Chief services agreement, which did not move forward because of RHFD.

Council stated their continued support to serve the residents and employees of the City of Pinole.

9. OLD BUSINESS

A. Presentation and discussion on Styrofoam Ban Ordinance [Action: Receive Report & Provide Direction (E. Casher)]

City Attorney Casher presented the report and provided an update on the proposed ordinance to prohibit the sale of polystyrene (Styrofoam) products within the City of Pinole, after 6 months of adoption. He stated that the City is required to comply with decreasing and eliminating trash entering waterways. Council asked questions and received responses.

At 9:45 p.m., Mayor Banuelos opened the Public Hearing, the following speakers addressed the Council:

Jon Jarvis, resident of Pinole, addressed the Council and stated his concern with trash in Pinole creek and encouraged Council to be environmental leaders in banning Styrofoam.

Ann Moriarity, resident of Pinole, addressed the Council and Pinole Creek Watershed and expressed her support in the proposed ordinance to remove trash from the water creek.

ACTION: <u>Council directed staff to continue discussion and bring back to Council in a future date.</u>

B. Receive and Update on the Rule 20A Project on Pinole Valley Road [Action: Receive Report & Provide Direction (T. Miller)]

Community Development Director/City Engineer Tamara Miller presented the report and provided an update to Council on Pinole Valley Road due to the West Contra Costa Unified School District – Pinole Valley High school project. She presented the project estimate costs and noted the budget shortfall and provided project options. Councilmember asked questions and received responses.

ACTION: Council directed staff to replace additional street light; use the existing power pole to mount the light or install a new pole, not in favor of reducing size of project limits
