Acknowledgement & Informational Handout

Directions for Property Owner: Please initial each statement below to signify you have read and understand what you may be responsible for as an owner builder. Note: A copy of the property owner's driver's license, form notarization, or other verification acceptable to the City of Pinole is required to be submitted with this documentaion to verify the property owner's signature.

1. I understand a frequent practice of unlicensed persons is to have the property owner obtain an "owner-builder" building permit which erroneously implies that the property owner is providing Initial his or her own labor and material personally. I as the owner-builder may be held liable and subject to serious financial risk for any injuries sustained by an unlicensed person and his/her employees while working on my property. My home owner's insurance may not provide coverage for such injuries. I am willfully acting as an owner-builder and am aware of the limits of my insurance coverage for injuries to workers on my property. 2. I understand building permits are not required to be signed by property owners unless they are responsible for the construction and are not hiring a licensed contractor to assume this responsibility. 3. I understand as 'Owner-Builder' I am the responsible party of record on the permit. I understand that I Initial may protect myself from potential financial risk by hiring a licensed contractor and having the permit filed in his/her name instead of my own. 4. I understand Contractors are required by law to be licensed and bonded in California and to list their license number on permits and contracts. 5. I understand if I employ or otherwise engage any persons, other than California licensed contractors, and Initial the total value of my construction is at least five hundred dollars (\$500.00) including labor and materials, I may be considered an "employer" under state and federal law. 6. I understand if I am considered an "employer" under state and federal law, I must register with the state and federal government, withhold payroll taxes, provide workers compensation disability insurance and contribute to unemployment compensation for each "employee". I also understand my failure to abide by these laws may subject me to serious financial risk. 7. I understand under California Contractors' State License Law, an Owner-Builder who builds singlefamily residential structures cannot legally build them with the intent to offer them for sale, unless all work is performed by licensed subcontractors and the number of structures does not exceed four within any

calendar year, or all of the work is performed under contract with a licensed general building Contractor.
